Updates

ICHE Transfer Guidance

On April 30, 2020, the Indiana Commission for Higher Education released a document titled “[Guidance on Transfer and Applicability of Courses Completed in the 2020 Spring Term](#)” related to COVID-19. Beginning on page three, grading scale information for students enrolled in the spring 2020 term at an Indiana public institution are included. Annual Reviews

Each year, ICHE conducts reviews and updates to ensure information accuracy. The [Core Transfer Library](#) (CTL) approval forms were due to ICHE on Friday May 15, 2020. AP and CLEP equivalency reviews were also due. AP/CLEP updates were collected by UTO and sent to ICHE last week. Campuses reviewed the new [Spanish with Writing Level I and II](#) CLEP exam and many have provided equivalencies to ICHE.

UTO is also conducting a TSAP website review for some of the IU locations and will be connecting with campus TSAP representatives over the summer to complete this review. Thank you to those who have and will take part in these reviews. We understand they take time and want to let you know we appreciate all you do for transfer students.

UTO Website

The student facing portion of the [UTO website](#) recently received some updates and is now more student friendly. Guaranteed Admissions

American Council on Education

The UTO Director currently serves on the ACE National Task Force on Transfer Credit as an advisor. ACE issued a statement on acceptance of 8 transfer credit principles ([See letter](#)). The principles asks that institutions be swift and immediate in its decision and communication regarding transparency of accepted and not-accepted grades and credits. While implementing policies and practices of transfer credit and knowing equal does not mean equitable, institutions must recognize the holistic burden students face, situationally and behaviorally.
