Articulation Agreement Repository Update

As mentioned in the [July](#) and [August 2020](#) issue briefs, UTO has been working with each IU campus to collect internal and external articulation agreements by October 30. We are pleased to report we have collected all official agreements, excluding TSAPs or Guaranteed Admissions agreements, from each campus. In total, we gathered over 75 unique articulation agreements between seven partner institutions outside IU, with a majority being full associate bearing agreements. Individual agreements and information, organized by campus, can be found [here](#). UTO also updated [articulation plans](#), a map of curricular coursework, not agreements, to take at each institution to fulfill a degree objective.

With increases in articulation agreements, UTO has developed an official articulation agreement template. The aim is to provide guidance on what must be included. Additionally we hope for some semblance in uniformity, increase in archiving and updating said agreements in the future, and adding data mining features. Communication will be provided to the IU transfer community once finalized. Please contact uto@iu.edu with questions regarding articulation agreements, submissions, and official IU degree articulation plan requests. **Note:** UTO will no longer collect agreements through the shared box folder due to box migration.
